<u>Teams –</u>

- 24 Varsity pairs max
- 24 JV pairs max
- Pairs must consist of two players from the same school (they do not have to have played together previously)

Registration -

- Email me the name of your pairs that will be participating
- The top 24 seeded pairs will be taken from each level, leaving the possibility that some pairs may not get in to the tournament at the Varsity level (since there are more teams there).
- Registration due date is Wednesday 10/6/21

Seeding -

- Seeding will be based on the total power point average of each player
 - Power point average it taken by adding up a player's top 12 finishes and dividing by that same number. Power points are given based on the level of win or loss. Point values are posted online.
- Your finish in pool play will determine your playoff seed.

Format –

- Pool play (two sets to 21, win by two, 25 pt. cap, 4 teams per pool), with all teams going to the playoffs (playoffs can be match or set play, depending on turnout).
- Playoffs are single elimination.
- Tournament format may change based on number of teams signed up.
- Gold medals will be awarded to the winning pairs from both Varsity & JV. Results and photos will be post on the league website.




